General Terms and Conditions for entering into Annual Rate Contract for the procurement of Chemicals, Bio-Chemicals- Glass wares, Plastic wares, Lab wares 2024-2025 for Thiruvalluvar University,

Vellore - 632 115.

General Instructions:

- 1. THIRUVALLUVAR UNIVERSITY, VELLORE, Tamilnadu, invites sealed bids for purchase of **Chemicals**, **Bio-Chemicals Glass wares**, **Plastic wares**, **Lab wares** from its manufacturer/authorized dealer for financial year **2024-2025 upto 3.00 p.m.** on **30.08.2024**.
- 2. Tender should be addressed to the Registrar, Thiruvalluvar University and should be only in sealed covers by Registered post/ or in person. Tenders received in ordinary covers without seal will not be considered. The tender is governed by the Tamilnadu Tender Transparency Act 1998 and 2000 as amended from time to time.
- 3. The tender cover should be superscribed as "Tender for the supply of with the words "Annual Rate Contract for the procurement of Chemicals, Bio-Chemicals- Glass wares, Plastic wares, Lab wares 2024-2025 to Thiruvalluvar University, Vellore. Due date on 30.08.2024.

Tender Opening:

- 4. The tenders will be opened on 30.08.2024 at 4.00 P.M. in the presence of the tenderers who are at present. Tenders received late will be returned to the tenderer unopened.
- 5. The entries in the tender schedule shall be as for as possible without scoring, corrections and over writings and shall be legible. The unavoidable correction or scoring shall be attested by full signature of the tenderer. The tenderer should sign on each page of the tender document.
- 6. In the tender schedule the tenderer should quote his discount for each item in separate sheet as per the format in figures and words in the corresponding column.
- 7. If the discount quoted in the schedule differs in words and figures, the highest discount rate will be taken. The unit rate shall be as per the price list given by the manufacturer.
- 8. The tender is in two-bid system i.e. Technical & Financial contains specification; and allied Technical details and the Price Schedule. The technical bid will be opened on the designated date by the REGISTRAR, THIRUVALLUVAR UNIVERSITY, VELLORE. The financial bid, **containing the discount percentage** will be opened on a suitable date, will be intimated later by the REGISTRAR, THIRUVALLUVAR UNIVERSITY in respect of those who qualify the terms and conditions of the technical bid.

Eligibility Criteria:

- 9. The Bidder's Firm should have been in existence for a minimum period of 3 years. (Copy of Certificate of Incorporation/ Registration Certificate of the Firm to be submitted). Copy of the PAN card of the firm. Copy of the IEC Code certificate (if applicable). Copy of the GSTN Registration. The Bidder must not be blacklisted/banned/suspended or have a record of any service related dispute with any organization in India or outside.
- 10. The Bidder should have 3 or more Rate Contracts with CSIR Labs / ICMR Labs /ICAR Labs /IIT Labs /Central Universities /DRDO /CFTI/ Govt. Organization in the past three years for similar items of this tender. Copies of such rate contracts must be enclosed with the offer.
- 11. The Bidder should have filed ITR for the last Three financial years i.e., FY (2021-22 & 2022 -23 & 2023-24) (Copy of the ITRs and filed acknowledgement to be submitted). If the Bidder is a local distributor/dealer/stocklist, it is mandatory to attach authorization certificate along with the bid from the manufacturing company.
- 12. Each tender shall be accompanied with the Tender cost of Rs. `1770 /- (cost 1500+GST (18%) 270) in the form of DD drawn in one of the Nationalized Banks in the name of "Registrar, THIRUVALLUVAR UNIVERSITY" payable at VELLORE. Or the tender cost amount shall be remitted in our University savings bank A/C no. 24840100000001, IOB, Serkkadu, IFSC Code IOBA0002484 and enclose the original remittance challan. Cheques and Bank Guarantees will not be accepted.
- 13. Tender fee **Rs. 1,770/-** will be Non-refundable amount of and the tenders submitted without tender cost shall liable to be rejected summarily.
- 14. The technical bid and the financial bid should be sealed by the bidder in separate covers super- scribed "Technical bid for Annual Rate Contract for the procurement of Chemicals, Bio-Chemicals- Glass wares, Plastic wares, lab wares" and "Financial Bid for Annual Rate Contract for the procurement of Chemicals, Bio-Chemicals- Glass wares, Plastic wares, lab wares". Both Sealed Envelopes should be kept in a main/ bigger envelope super-scribed as "Annual Rate Contract for the procurement of Chemicals, Bio-Chemicals- Glass wares, Plastic wares, Lab wares 2024-2025". The "Technical Bid" will be analyzed and 'Financial Bid' containing the discount percentage of only those firms who are found eligible in 'Technical Bid' will be opened in due course and the eligible firms would be intimated there of accordingly.
- 15. Any conditional tender shall be rejected summarily.
- 16. Proposal for rate contract may be submitted in the prescribed format and all columns may be filled up. Incomplete proposals and tenders received after due date shall not be entertained. THIRUVALLUVAR UNIVERSITY shall not be responsible for any postal delay and delay in receipt of the offer. Any bids received by the University which does not fulfill the desired terms and conditions shall be rejected out rightly and no communication in this regard shall be sent. Delayed / Late Bids

will not be accepted, at any circumstances.

- 17. Each tender shall be accompanied with the EMD of **Rs.10,000** (Rupees Ten Thousand Only) in the form of DD drawn in one of the <u>Nationalized Banks</u> in the name of "REGISTRAR, THIRUVALLUVAR UNIVERSITY" payable at VELLORE or the EMD amount shall be remitted in our University savings bank A/C no. 248401000000001, IOB, Serkkadu, IFSC Code IOBA0002484 and enclose the original remittance challan. Cheques and Bank Guarantees will not be accepted.
 - **a)** No request for transfer of any pervious deposit of earnest money or security deposit or payment of any pending bill held by the institute in respect of any previous work will been pertained.
 - **b)** Tender shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited to the THIRUVALLUVAR UNIVERSITY, VELLORE.
 - c) The Tenders without Earnest Money will be summarily rejected.
 - **d)** The firms who are registered with National Small Industries Corporation (NSIC) / OR Small Scale Industrial(SSI) are exempted to submit the EMD (copy of registration must be provide along with)
 - **e)** No Claim shall lie against the REGISTRAR, THIRUVALLUVAR UNIVERSITY, VELLORE in respect of erosion in the value or interest on the amount of EMD.
 - f) The EMD, in case of successful bidders shall be returned after submission of performance security and in case of unsuccessful Bidders shall be retained by the Purchaser, upto a maximum period of 6 months from the date of opening of the Bids or till the finalization of the tender, whichever is later. The bid security shall be refunded to the unsuccessful tenderers on written request. No interest will be payable by the THIRUVALLUVAR UNIVERSITY, VELLORE authorities on the EMD.
 - **g)** In case the tenderer withdraws, modifies or change his offer during the contract period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof.
- 18. The Manufacturers (OEMs) / principals offering for the Rate Contract may furnish the name and address of their local authorized distributor / dealer, so that the copies of orders can be endorsed to them for expeditious supply. In such cases where local dealers/stockiest has been nominated by the principal, the bills raised by them against our purchase order will be accepted.
- 19. Any addition and deletion of authorized dealership / distributorship shall be intimated to the undersigned immediately on authorization of a new party.
- 20. The tenderer is at liberty either himself or authorize not more than one representative to be present at the opening of the tender. The representative attending the opening of the tender on-behalf of the tender should bring with him a

letter of authority from the tenderer and proof of identification.

Submission of Tenders:

- 21. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason or decision, modify the terms & conditions of the tender document by a corrigendum displayed on the website of THIRUVALLUVAR UNIVERSITY, VELLORE (http://www.tvu.edu.in). In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
- 22. Printed & bound price list for 2024-2025 (Both hard copy and soft copy) duly signed & certified by authorized signatory must accompany the tender. Photocopy of the price list and price list in spiral binding will not be accepted. The price list which is in CD may be downloaded and a copy may be supplied to this office duly signed and sealed by authorized signatory.
- 23. An undertaking may be given that the price list being furnished with the proposal will remain valid for the current rate contract irrespective of validity period.
- 24. Trade discount along with certificate certifying that higher discount is not given to any other Department/Organization/Institution than offered should be enclosed with Financial Bid. In case of discrepancy between unit price & total price, the unit price shall prevail.
- 25. The percentage of discount quoted by each firm in tenders be given both in words and figures failing which the same is liable to be rejected. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders.
- 26. A Certificate to be given by the tenderer that the price list supplied is the only one in circulation.
- 27. In case the price list for the previous year is still valid for the entire period of rate contract for the year 2024-2025 a certificate to this effect may please be furnished duly signed by the authorized signatory.
- 28. Authorization certificate in respect of foreign firms duly self-attested and showing validity period may be submitted.
- 29. Individual signing the tender or other documents connected with contract must specify whether he sign as:
 - (a) A sole proprietor of the concern or constituted attorney of such sole proprietor;
 - (b) A partner of the firm, if it is a partnership firm in which case he must have authority to execute the contract son be half of the firm and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firm.

- (c) The Head or a principal officer duly authorized by the Board of Directors of the Company, if it is a company.
- 30. The bids prepared by the bidder shall comprise of (1) Technical Bid and (2) Financial Bid:

Technical Bid:-To qualify in the Technical Bid the firm should have the minimum eligibility criteria as under and the firm in this regard must submit the following documents in support of their eligibility criteria:-

- (a) Valid registration certificate of the firm of the Govt./State Govt.
- (b) Duly filled format of Technical Bid
- (c) Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / firm / agency etc.
- (d) Price list of the items from the Principal
- (e) Manufacturer Authorization Certificate from the principal must be attached by Bidder.
- (f) PAN number with document
- (g) GST with document
- (h) The bidder shall be a Manufacturer / Distributers / Suppliers / Agents.
- (i) Financial Status: The average annual turnover from similar jobs, of the quoting firm should not be less than 1 crore in the last three consecutive years. Copies of profit & loss account and balance sheets duly authenticate by a Chartered Accountant for the last three years should be enclosed.
- (j) The Technical bid should be accompanied by Demand draft of Rs.1,770/(inclusive of GST)(non-refundable) against tender fee and Demand Draft of Rs.
 10,000/- (Rupees Ten Thousand only) for EMD in favor of "REGISTRAR,
 THIRUVALLUVAR UNIVERSITY" payable at VELLORE or the EMD amount shall
 be remitted in our University savings bank a/c no. 248401000000001, IOB,
 Serkkadu, IFSC Code IOBA0002484 and enclose the original remittance
 challan.
- (k) Copy of Income Tax Return Acknowledgement for last Three years.
- (I) Copy of PAN Card.
- (m) Copy of GST registration certificate.
- (n) Registration with Excise Department, Govt. of India. The industries situated in excise free zones will be exempted from registration provided they produce the copy of appropriate notification.
- (o) Details of clients where similar services are presently provided by the tenderer separately for govt. and private clients.
- (p) The concerned firm/company whose product has been declared as of spurious or adulterated quality and any criminal cases is filled and is pending in any court shall not be eligible to participate in the bidding process. Convicted firms/company shall also not be eligible to participate in the bid. Similarly, blacklisted / banned / debarred firms / company by any central / state govt. or its organization or autonomous bodies or central drug procurement agency is not eligible to participate in the bid.

Financial Bid:

- (a) Price Bid Form, the percentage of the discount of Price must be quoted as per format specified, failing which tender shall be summarily rejected.
- 31. A person signing the tender form or any document forming part of the tender on behalf of another person should have an authority to bind such other person and if, on enquiry it appears that the person so signing had no authority to do so, THIRUVALLUVAR UNIVERSITY, VELLORE may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.
- 32. The tenderer should sign and affix his firm's stamp at each page of the tender and all its annexure as the acceptance of the offer made by tenderer will be deemed as a contract and no separate formal contract will be drawn. **NO PAGE SHOULD BE REMOVED/ DETACHED FROM THIS NOTICE INVITING TENDER**.
- 33. The award of the tender shall be made strictly in accordance with the Tamilnadu Transparency Tenders Act 1998 and Rules 2000 and no deviation will be made.
- 34. The THIRUVALLUVAR UNIVERSITY, VELLORE reserve the right to accepting the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. The THIRUVALLUVAR UNIVERSITY, VELLORE reserve the right to reject any or all tenders / quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.
- 35. Enlistment under Rate Contract with this Institute does not ensure business of any quantum, whatsoever. Any deviation from the Terms & Conditions mentioned above will imply disqualification for the firm
- 36. The tenderer whose tender has been accepted will be notified by the Tender Accepting authority, in writing.
- 37. For Successful tenderer, EMD will be converted to Security Deposit and will be retained with Thiruvalluvar University until the expiry or termination of the rate contract without interest.
- 38. The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contractor for unsatisfactory performance or non-observance of any condition of the contract. Performance Security will be discharged after completion of contractor's performance obligations under the contract.
- 39. In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/job without assigning any reason there of and nothing will be payable by THIRUVALLUVAR UNIVERSITY,

VELLORE in that event the security deposit shall also stands forfeited.

40. If any conflict or difference arises concerning this agreement, its interpretation on payment to the made there- under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing The REGISTRAR, to be appointed by UNIVERSITY, VELLORE. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

OTHER CONDITIONS:

- 41. The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of THIRUVALLUVAR UNIVERSITY, VELLORE, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.
- 42. Delivery of goods shall be made by the supplier within 30days of placing of purchase order, however, in case of emergent requirement he has to supply the required quantity of **goods within one or two weeks** of placing of order also. In few cases the items are to be delivered at a very short notice i.e. within 24 hours.
- 43. Supply of material will have to be completed within 30 days or period mentioned in the purchased order. The liquidated damages charges @0.5% per week shall be imposed if supply made after expiry of delivery period subject to maximum 10% of the total value of goods/contract value. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.
- 44. The bill in triplicate may be sent to this office for settlement after satisfactorily delivery of the material. The bill should have full particulars of the items(s).
- 45. No payment shall be made in advance nor shall the loan from any bank or financial institutions be recommended on the basis of the order of award of work.
- 46. If successful tenderer fails to supply material within the stipulated delivery date or material supplied other than specification specified in tender, The Registrar, THIRUVALLUVAR UNIVERSITY, VELLORE reserves the right to procure same or equivalent material from alternative sources at the vendor's risk, responsibility and cost. Any extra cost incurred in the procurement of the material from alternative source will be recovered from the Security Deposit / Bank Guarantee

- and Pending Bills and if the value of the materials under risk purchase exceeds, the amount of Security Deposit and / or Bank Guarantee and Pending Bills, the same may be recovered if necessary by due legal process.
- 47. The contractor shall submit the bill only after supply of the material to the satisfaction of the THIRUVALLUVAR UNIVERSITY, VELLORE, on receipt of a prereceipted bill invoice from the Contractor the case of issuing sanction and passing of bill for payment will be initiated. No payment will be made for goods rejected.
- 48. The agreement shall be deemed to have been concluded in **VELLORE** and all obligations hereunder shall be deemed to be located at **VELLORE** and Court within **VELLORE** will have Jurisdiction to the exclusion of other courts.
- 49. The tender is initially for financial year 2024-2025 and may be extended till new Rate Contract gets final, if required.
- 50. THIRUVALLUVAR UNIVERSITY, VELLORE shall, however, reserve the right to terminate the contract at any time without assigning any reason.
- 51. The items will have to be supplied at THIRUVALLUVAR UNIVERSITY, VELLORE. No transportation/ cartage charges will be provided for the same. The firm may supply the required items as per unit price mentioned in the pricelist.
- 52. The articles should be securely packed to avoid damages etc. in transit.
- 53. The REGISTRAR, THIRUVALLUVAR UNIVERSITY, VELLORE shall be the sole authority to cancel or amend the order, as per requirement, and also to place order for supply of item beyond office hours/holidays/place of supply for which, no additional payment shall be made.
- 54. In case a proposal is accepted the supplier/principal will have to sign an agreement deed with us on a non-judicial stamp of appropriate value while entering into rate contract.
- 55. The material shall be delivered at THIRUVALLUVAR UNIVERSITY, VELLORE with remaining shelf-life of at least 75% of the stipulated total shelf-life from the date of manufacturing of that product.
- 56. Order shall be issued for tentative annual requirement on actual need basis. Bills in triplicate for the items supplied by the selected firm(s), should be raised for payment. Payment shall be released after it is ensured that the items/quantity and quality of items supplied are to the entire satisfaction of this office and accepted. If any item is found to be defective, or not of the desired quality, the same shall be replaced immediately, for which no extra payment shall be made by THIRUVALLUVAR UNIVERSITY, VELLORE.

- 57. The selected tendering Firm/Agency/Company shall also provide the name and mobile number of a key person, who can be contacted at anytime, even beyond the office hours on holidays. The person should be capable of taking orders and making arrangement for supply of the desired items even on short notice to THIRUVALLUVAR UNIVERSITY, VELLORE.
- 58. In case the quality of goods supplied are not in conformity with the standard given in tender or the supplies are found defective at any stage these goods shall immediately will be taken back by the supplier and will be replaced with the tender quality goods, without any delay. The REGISTRAR, THIRUVALLUVAR UNIVERSITY, VELLORE, reserves all right to reject the goods if the same are not found in accordance with the required description / specifications and liquidates damages shall be charged.
- 59. Each page of the Tender Notice to be signed and stamped by the bidder in token of having accepted the same.
- 60. The Discount which will be offered by the manufacturer/authorized distributors on the manufacturer's price list for the year 2024-2025 may be mentioned. Firms must offer a flat discount rate on all items instead of separated is count on different items like culture media, chemicals etc.
- 61. Authorization letter from the manufacturer for the current financial year should be submitted along-with quotation, failing which quotations will not be considered. The rate of GST should be mentioned clearly.
- 62. The THIRUVALLUVAR UNIVERSITY, VELLORE reserves the right to place an order for supply of any items mentioned in the Financial Bid or otherwise, to any other firm(s) in emergency/unavoidable situation.

63. Special Conditions:

- (a) Freight, insurance charges, if any will be borne by the supplier, Similarly shortage, pilferage in transit will be sole responsibility of the supplier and the same will be intimated to the supplier on receipt of goods by the purchaser for resupply. The defective supply will have to be replaced by the supplier within 10 days without additional freight / transport charge.
- (b) GST and other Govt. levies will be paid extra as applicable by the supplier.
- **(c)** Delivery of goods will be taken at the risk and cost of the supplier and on F.O.R. basis to the Institute from railway / road transport.
- (d) Payment of the bill will be made preferably after receipt of the goods in satisfactory condition.
- (e) No revision in rate (on higher side) will be accepted during contract period.
- (f) Order will be placed as per requirement, irrespective of value of the order.
- **(g)** Supply should be made in full against the order and shortage will be procured from other supplier on the risk and cost of the original supplier.
- **(h)** Supply should be made from the latest batch of production with maximum life period & original packing.

- (1) While submitting the tender document, the tenderer should sign on each page of the tender document.
- (1) The tenderer should enclose a signed copy of the terms & conditions stipulated for award of the contract, conveying his acceptance of the same.
- 64. The near relatives of employees of THIRUVALLUVAR UNIVERSITY, VELLORE are prohibited from participation in this tender. The near relative for this purpose are defined as:
 - (a) Members of a Hindu undivided Family.
 - (b) Their spouses
 - (c) The one related to the other in the manner as father, son(s), Son's wife (daughter-in-law), daughter(s) and daughter's husband (sons-in-law) brother (s) and brother's wife, sister(s) and sister's husband, brother(s)-in-law.

Inspection:

- (a) THIRUVALLUVAR UNIVERSITY, VELLORE shall have the right to inspect and/or to test the goods to confirm their conformity to the THIRUVALLUVAR UNIVERSITY, VELLORE Tender Specifications at no extra cost to the THIRUVALLUVAR UNIVERSITY, VELLORE right to inspect, test and, where necessary, reject the Goods after the goods arrival at the final destination shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by THIRUVALLUVAR UNIVERSITY, VELLORE prior to the goods shipment.
- **(b)** The REGISTRAR, THIRUVALLUVAR UNIVERSITY, VELLORE shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other terms and conditions.
- **(c)** No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within two (02) weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

The Registrar
