Sealed Tenders are invited for the Transportation of confidential materials from Thiruvalluvar University to affiliated colleges for Nov/Dec2022 and April/May 2023 university examinations.

#### **Terms and Conditions:**

- The sealed tender should be addressed to the "The Registrar, Thiruvalluvar University, Serkkadu, Vellore- 632 115.
- 2) The cover should be sealed properly and super scribed as "Tender for Transportation of confidential materials from Thiruvalluvar University to affiliated colleges for Nov/Dec.2022 and April/May 2022 University Examinations will be opened on 09.12.2022 at 04.00P.M.
- 3) The complete set of tender documents can be downloaded from the websites <a href="www.tvu.edu.in">www.tvu.edu.in</a> and the cost of tender document is Rs. 1770/- shall be paid in the form of Demand Draft drawn in favor of Registrar, Thiruvalluvar University, Serkkadu, Vellore or remitted the amount in our University savings bank a/c no. 24840100000001(IFSC IOBA0002484, IOB, SERKKADU) through RTGS/NEFT and enclose the original Bank remittance challan with tender document.
- 4) The tenderers shall be furnish as part of its tender, an Earnest Money Deposit of Rs.5,000/- in the form of Demand Draft drawn in favor of the Registrar, Thiruvalluvar University, Serkkadu, Vellore or remitted the amount in our University savings bank a/c no. 24840100000001(IFSC IOBA0002484, IOB, SERKKADU) through RTGS/NEFT and enclose the original Bank remittance challan with Tender document.
- 5) The **EMD** paid will be adjusted for Security Deposit for the successful Tenderer. Tenders received **without EMD** will be rejected as non-responsive tender. If any tender is withdrawn after acceptance, the EMD/Security Deposit will be forfeited.
- 6) The tender is valid for a period of Nov/December 2022 and April/May 2023

Examinations only. No request for enhancement of rates will be admitted during the contract period.

- 7) The rates should be valid from the date of opening of the tender and up to the date of end of the contract period.
- 8) The tenderer should quote rates only in the format prescribed by this office in the **Annexure–II** attached. Any addition or deletion or omission in this format is not permitted and such changes in the Tender by the Tenderer will be summarily rejected.
- 9) If any tender is made by an individual it shall be signed with his full name and his address should be given. If it is made by a firm, it shall be signed by the all the partners or by holders of their power of attorney or a partner of the firm duly empowered to do so. The full name and address of all the partners with a copy of partnership deed shall be furnished.
- 10) Telex, Cable, Facsimile tender will not be accepted. The tender will be received at the address as indicated above and tender received after 03.30 P.M. on.09.12.2022 will not be accepted.
- 11) The Contractor should submit the copy of Experience Certificate (Client Certificate)/Copy of work order for having at least **two years** of experience in this field.
- 12) The Successful Tenderer, should execute the agreement in stamp paper to the value of Rs.100/-. The draft agreement will be supplied by the Thiruvalluvar University, Serkkadu, Vellore.
- 13) The reference Number of the enquiry should be quoted in your offer.
- 14) The rates should be quoted clearly both in figures and words in the tender schedule.

  The taxes that may be applicable should be quoted separately and specifically. The corrections if any should be attested by the authorized signatory.
- 15) List of stations where they have their own booking offices/delivery stations within Tamil Nadu should be furnished. In case of consignments booked to stations where the contractor no branch or agency for the door delivery of the consignments the contractor should arrange for transport and effect the door delivery/collection of the consignments through some other transport contractor or agent at his own cost, risk and responsibility.
- 16) The Vehicle must be closed and covered with lock and key facility. Contractors having

- their own vehicles minimum Five vehicles with registered numbers for the transport consignments and minimum Rs.5.00Lakhs (Rupees Five Lakhs only) turnover for the last one year alone need to apply.
- 17) The undelivered goods should be returned to the consignor without collecting any demurrage or other charges immediately.
- 18) On receipt of intimation from the Controller of Examinations, Thiruvalluvar University for transportation of confidential materials from Thiruvalluvar University to Affiliated Colleges and vise versa, the tenderer should arrange to collect/distribute the confidential materials and send intimation to the Controller of Examinations which the goods are delivered /collected.
- 19) The payment towards services will be made only on submission of summary of account for transported along with 100% proof of delivery (POD) and other related documents duly certified by the Controller of Examinations. On receipt of the submission of the summary statement along with POD and other related documents, payment will be made within 15 days from the date of receipt of the above records.
- 20) Liquidated Damages: Incase of delayed delivery, Liquidated Damages at 0.50% per week on value of bills object to a maximum of 50% will be levied.
- 21) In case of loss/damage of any parcels, during transportation, the cost there for as decided by the Thiruvalluvar University will be deducted from the payments.
- 22) Tendering Authority of Thiruvalluvar University reserves its right to cancel the contract without prior notice, if the service is found unsatisfactory.
- 23) The sealed tender will be opened at 4.00 P.M on 09.12.2022. The tenderers may present if they so desire or the tenderers can sent their representatives at the time of opening of the tender with proper letter of authorization.
- 24) The Tender Accepting Authority reserves the right to accept or reject any tender without assigning any reasons there for.
- 25) In case any disputes arises, the decision of the Tender Accepting Authority, Thiruvalluvar University is final and binding.
